## **Final Orders**

## (In respect of Complaint Case No. HRTSC/Comp-02/MSME/2024-Complaint regarding-Disbursement of testing equipment assistance. From:-Sh. Vipin Sardana (M) 98962-32889. Email:- Vipin.Sardana@carus.in

- These orders are in continuation of interim orders of the Commission dated 20.07.2024 which be read as part and parcel of these orders. Two specific questions were raised in those orders which are as under:-
  - When the case was reflected on the id of Sh. Shashi Kant, the then Additional Director after July, 2023 before its approval on 18.09.2023?
  - (ii) When the applicant/ the complainant uploaded the documents i.e. bank details, affidavit and the declaration on the portal and why they were not visible till 04.01.2024?
- 2. In response, a reply bearing memo no. MSME/RTS/2024/2152 dated 30.05.2024 has been received from Deputy Director (RTS) without specifying whether this reply has the approval of the Director General or not. Anyways, since specific questions were asked, and the reply is factual, same is taken on record. It states the following:-

- 3. The Commission has carefully considered all facts and circumstances of this case. It is evident that the case was reflected on the id of Sh. Shashi Kant from 25.07.2023 and he did not take any action on this application till 18.09.2023. Moreover, when the bank details were submitted by the applicant on 25.09.2023, no action was taken on this till 04.01.2024 delaying the release of subsidy in this case. There is no justifiable reason for Sh. Shashi Kant to hold back this case because of which amount of Rs.11, 65,000/- could not be disbursed to the applicant for a long time. Therefore, holding Sh. Shashi Kant, the then Additional Director, Industries and now posted as XEN in Haryana Power Generation Corporation Ltd., the Commission in exercise of its powers under Section 17 (1) (h) of the Act, imposes a token penalty of Rs. 5,000/- on him. He is further directed to pay a compensation of Rs. 5,000/- to the applicant for this inordinate delay. Managing Director, HPGCL is directed to deduct Rs. 10,000/from the salary of Sh. Shashi Kant for the month of July, 2024 to be paid in August, 2024 and deposit Rs. 5000/- in the State Treasury under the Receipts Head 0070-60-800-86-51 and disburse Rs. 5,000/- to the applicant. Sh. Vipin Sardana is requested to provide the following details of Carus Laboratories Private Limited to the office of MD, HPGCL (md@hpgcl.org.in) as well as to the Commission for the purpose of disbursement of this compensation in it's bank account:-
  - 1. Name of the Bank
  - 2. Name of the Account holder in the Bank
  - 3. Bank Account Number
  - 4. Address of the Bank
  - 5. IFSC Code

The amount of compensation will be paid in the bank account of the entity which was eligible for subsidy in this case i.e. Carus Laboratories Private Limited and not in the individual bank account of any person. MD, HPGCL is directed to send compliance of these orders by 10.08.2024 positively.
