### **Final orders**

#### **(In respect of Comp-327/ULB/2023- Application pending beyond RTS timelines with Urban Local Bodies of District, Mahendergarh)**

On perusal of SARAL reports as on 14.10.2022, 199 cases of notified services were found pending beyond RTS timeline with the ULBs of Mahendergarh. Taking cognizance of the matter, the Commission sought a report from Sh. Anurag Dhalia, HCS, District Municipal Commissioner, Mahendergarh, Haryana for these services, vide letter dated 31.10.2022. These included 8 cases of service- Change of Owner/Occupier in Property Tax Register (except in death case) pertaining to Municipal Committee, Kanina. A report dated 28.11.2022 was in turn received from District Municipal Commissioner attaching a report dated 24.11.2022 from Municipal Committee, Kanina in which details of 8 cases had been given. All cases pertained to Change in ownership in Property Tax Register (except in death case) and the reason for delay caused in these cases was mentioned as "Admin and Level 2 Id Created in October 2022". Except in case at sr. no. 6, all cases had been delayed by more than 30 days. Sh. Mukesh Kumar, Secretary, MC Kanina has been held responsible for the delay caused in these cases by the respondent.

2. In view of the above, a report was sought from him vide a show cause notice letter no.763 dated 16.02.2023 for which no response was received from him. To proceed further in the matter, a hearing was scheduled to be held under the chairmanship of Sh. T.C. Gupta, Chief Commissioner, Haryana Right to Service Commission on 13.04.2023 at 10.30 am which was conveyed to Sh. Mukesh Kumar, Secretary, MC Kanina vide Commission's letter no. 1369 dated 03.04.2023 which was not attended by him neither any response was received from him. Subsequently, a reminder was sent to him from the Commission to send reply vide letter dated 13.04.2023 but when no reply was received, a hearing was fixed vide letter dated 04.05.2023 of Shri Mukesh Kumar alongwith other officers of MC, Narnaul and MC, Mahendergarh to be held before Shri T.C. Gupta, Chief Commissioner, HRTSC on 16.05.2023 at 11.00 am. Then also, Shri Mukesh Kumar did not bother to attend the hearing even though a telephonic message had been given to him. Consequently, he was given another opportunity vide letter dated 18.10.2023 to send the reply by 31.10.2023 and to appear for personal hearing at 10.00 am on 06.11.2023. The hearing scheduled for 6.11.2023 was rescheduled for 14.11.2023 at 11.00 am. He again failed to attend the
